

COMMON COUNCIL MEETING RESULTS

1. OLD BUSINESS

- a. **Resolution CC-03-19-18-03**: A Resolution of the Common Council of the City of Carmel, Indiana, Granting a Waiver that Certain Private Streets be Improved to City Standards Before Being Dedicated to the City; Sponsor: Councilor Green. **REMAINS IN THE FINANCE, UTILITIES AND RULES COMMITTEE.**

Synopsis:

Grants a waiver to allow the city to accept a dedication of right-of-way for the private streets located within the Mayflower Business Park.

- b. **Second Reading of Ordinance D-2430-18**; An Ordinance of the Common Council of the City of Carmel, Indiana, Adding Section 6-83 to Chapter 6, Article 4 of the Carmel City Code; Sponsor: Councilor Worrell. **REMAINS IN THE LAND USE AND SPECIAL STUDIES COMMITTEE.**

Synopsis:

Prohibits camping in a vehicle on public property in the City of Carmel.

3. NEW BUSINESS

- a. **Resolution CC-08-06-18-01**: A Resolution of the Common Council of the City of Carmel, Indiana, Approving a Transfer of Funds Between the 2018 Building Operations Budget (1208) and the General Administration Budget (1205); Sponsor(s): Councilor(s) Worrell and Kimball. **ADOPTED**

Synopsis:

Transfers \$60,743.24 from Line Item 4358901 – Other Exp. Mohawk Landing within the 2018 Building Operations Budget into Line Item 4467099 –Other Equipment within the 2018 General Administration Budget.

- b. **Resolution CC-08-06-18-02**: A Resolution of the Common Council of the City of Carmel, Indiana, Approving the Issuance of Bonds by the Carmel Clay Public Library; Sponsor(s): Councilor(s) Carter, Rider and Worrell. **TABLED**

Synopsis:

Resolution approves the issuance of bonds by the Carmel Clay Public Library for the purpose of funding the cost of the acquisition of real estate and the renovation of and

improvements to library facilities, including the purchase of equipment and technology. Such bonds will be payable solely by the Library and once issued are not expected to increase the tax levy of the Library.

- c. **Resolution CC-08-06-18-03**: A Resolution of the Common Council of the City of Carmel, Indiana, Regarding an Intergovernmental Transfer of Real Property Interest; Sponsor: Councilor Worrell **ADOPTED**

Synopsis:

Transfer of property located at 41 E. City Center Drive from the City of Carmel to the Carmel Redevelopment Commission.

- d. **First Reading of Ordinance D-2432-18**: An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 6, Article 5, Division VIII, Section 6-158 of the Carmel City Code; Sponsor: Councilor Campbell. **SENT TO THE LAND USE AND SPECIAL STUDIES COMMITTEE.**

Ordinance clarifies the regulation of noise within the City of Carmel.
