

COMMON COUNCIL MEETING RESULTS

1. PUBLIC HEARINGS

- a. **First Reading of Ordinance D-2449-18**; An Ordinance of the Common Council of the City of Carmel, Indiana, Authorizing and Approving an Additional Appropriation of Funds from the Operating Balance of the General Fund to the 2018 Carmel Fire Department Budget; Sponsor: Councilor Finkam. **ADOPTED**

Synopsis:

Appropriates funds to the 2018 Carmel Fire Department budget that were received by the City from Clay Township to cover the cost of medical exams.

2. NEW BUSINESS

- a. **Resolution CC-12-03-18-01**: A Resolution of the Common Council of the City of Carmel, Indiana, Approving a Transfer of Funds Within the 2018 Information & Communication Systems Department Budget; Sponsor(s): Councilor(s) Carter and Finkam. **ADOPTED**

Synopsis:

Transfers \$188,000 from Personnel Services Line Items to the Communication Equipment, Hardware and Software Line Items within the 2018 Information & Communication Systems (ICS) Department Budget.

- b. **Resolution CC-12-03-18-02**: A Resolution of the Common Council of the City of Carmel, Indiana, Approving a Transfer of Funds Within the 2018 Motor Vehicle Highway Fund Budget; Sponsor: Councilor Worrell. **ADOPTED**

Synopsis:

Transfers \$100,000 from various line items to the Other Contracted Services Line Item within the 2018 Motor Vehicle Highway Fund Budget.

- c. **Resolution CC-12-03-18-03**: A Resolution of the Common Council of the City of Carmel, Indiana, Approving a Transfer of Funds from the 2018 Department of Administration Budget and 2018 Carmel Fire Department Budget Into the 2018 Carmel Building Operations Budget; Sponsor: Councilor Finkam. **ADOPTED**

Synopsis:

Transfers \$213,000.00 from various line items in the 2018 Department of Administration Budget and the 2018 Carmel Fire Department Budget into the Electricity Line Item within the 2018 Carmel Building Operations Budget.

- d. **First Reading of Ordinance D-2446-18**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 2, Article 4, Section 2-102 of the Carmel City Code; Sponsor: Councilor Worrell. **SENT TO THE FINANCE, UTILITIES AND RULES COMMITTEE.**

Synopsis:

Establishes a Carmel Redevelopment Commission Marketing Gift Account Fund.

- e. **First Reading of Ordinance D-2447-18**; An Ordinance of the Common Council of the City of Carmel, Indiana, Adding Subsection (65) to Chapter 8, Article 5, Section 8-47(a) of the Carmel City Code; Sponsor: Councilor Worrell. **ITEM WAS HELD OVER UNTIL THE NEXT MEETING AND NOT SENT TO COMMITTEE**

Ordinance prohibits parking on a certain section of Pebblepointe Pass.

- f. **First Reading of Ordinance D-2448-18**; An Ordinance of the Common Council of the City of Carmel, Indiana, Amending Chapter 6, Article 5, Division VIII, Section 6-158 of the Carmel City Code; Sponsor: Councilor Carter. **SENT TO THE LAND USE AND SPECIAL STUDIES COMMITTEE.**
